ASSENT REQUIRED FOR ACCESS TO POMERENE FACEBOOK PAGE

BY POSTING ON THIS POMERENE HOSPITAL FACEBOOK SITE YOU AGREE TO THESE TERMS. Pomerene Hospital has opened this publicly facing site on Facebook for viewing content and/or videos and posting comments about Pomerene. By accessing, viewing and/or posting any content related directly or indirectly to Pomerene on this site, you accept, without limitation or qualification, the following terms of use. If you do not agree to the terms of this Policy, you may not view or post any content to this site. Your use of this site is acceptance of this Policy and has the same effect as if you had actually physically signed an agreement.

1. If you are a Pomerene employee, you must adhere to the POMERENE SOCIAL MEDIA POLICY found in Section 5 of the Employee Handbook.
2. You must be at least 18 years old to post any content to this site.
3. You are prohibited from posting any content that is personal health information including patient images on this site. You are also prohibited from using the site to provide medical advice or medical commentary by non-Pomerene physicians or to use the site to make, recommend or increase referrals to physicians who are not employed by Pomerene Hospital.
4.
